## ii. 2016-17 program highlights

Last Year: Achieve 3000 program for literacy was implemented. With first year of use we had 14 students complete over 40 lessons average lexile 540 (4th grade level), those students ended at a high 6th grade reading level.

This year: Big emphasis on stretch goals. At PD trainer for Achieve 3000, showed instructors how to implement. Goal of students reaching 80 lessons. Reaching out to Bryan from UofM, wants to partner with to have a master's candidate visit. Data organization will give answers. Implementing soft skill scores.
