#### C. Audit Presentation All audits are due Nov. 1<sup>st</sup> to State of Michigan. Croskey Lanni, PC deals with mostly charter schools. They deal with 52 charter schools currently. These audits will be

made public as they are public dollars being funded and being spent, anyone can look up 7 years of audits on any publicly funded entity.

Page 2 Roman numeral – Independent auditors report – the financial statements present fairly in all materials and respects of Jackson Preparatory & Early College. Page 5 Roman numeral – Managements discussion and analysis – What occurred at the academy during the year and how did you form against your budget. This is a story of JPEC.

Page 3 – Snapshot of a day – June  $30^{th}$ , 2016. Fund balance = savings during year. Page 4 – Statement of Revenues – most dollars are public dollars. Treasury, 5% list (targeted schools/ MI d\Dept of Treasury). They compare fund balance to 1 years' worth of revenues. We plan on being on this list this year.

*Page* 6-13 - *Notes to the financial statements* – *most charter school notes will look similar.* 

*Note #4 on page 12 – Title I & II* 

*Note #6 page 13 – details on lease. Lease has not increased as of yet, but is an annual conversation and can increase.* 

Page 14 – Original budget against final budget against actual numbers. If you have exceeded the budget you will be receiving a letter that states that you have exceeded your final budget, what is your plan, provide internal controls and processes, and how will you prevent this from happening. State of MI looks at expenditures against appropriations. No state law that states we have to be within the 5%, just a dry calculation. Wants 5% revenues in fund balance.

Pages 15-17 – Details of financial statements – pg 16 ~\$140,000 additional startup cost that was billed by authorizer that was not planned. Not enough detail to break \$140,000 out, entire amount with go under general admin.

Page 18 – Schedule of findings and responses – budget finding that appropriations exceeded expenditures of \$21,590.

Page 19 – Advanced drawdown – those findings from the prior year have been corrected.
