B. 2016-17 Budget Amendment

Motion to accept 2016-17 Budget Amendment made by S. Hogwood and seconded by Zoe Wilcox.

Student allowance was increased. Increased dual enrollment to \$705,000 (\$105,000 increase). Decrease technology budget line, were able to receive additional funds through grants. Increase in Title I dollars (at 37% mark) and At Risk (section 31a) funds (just above 54%). Instructional expenditures, CP salaries remain consistent, EC is increased because of new hires. Cultural immersion (online language learning), this line has been adjusted to Art. Original salary increases are mostly 3% increases, some did receive higher increases because of position changes and education changes. *Finance committee to discuss merit based raises for next year, bring back to board along with budget committee policies. Total expenses at \$2.8, ending balance is positive. Total fund balance `\$325,000 or 11%.

i. Financial Statements – September

Received some revenue from Title I funds (\$37,000). Local revenue line is mainly Pay-To-Play and AUP payments. Expenditures are mainly salaries and computers (~\$46,000). Showing a loss because of adjusted state aid payment (Count day numbers) that won't be presented until January 2017 roughly. Will not need to take out loans.

ii. Enrollment – Count Day Update

Counted 379 students, an increase of 92 students from last spring. Section
25 has been filed for the addition of students.

iii. Annual Education Report sample/update 2015-16 data will not be available until late fall.

iv. HR Update

New HR Rep for Employee's Only: Marquita Tharpe. No open positions. All teachers are certified and up to date. Evaluations of the board, discussion for future meetings.

B. Provost's Report

i. Teacher Evaluation System – 5 D's State is moving towards this system and are beginning to support it financially.
