DISCIPLINARY HEARING

Parent asked to go into closed session.

Motion to go into open session - Rando, Second - Halsey, Unanimous. Approved. 6:44pm. Motion to move forward with 45-day alternative learning placement with home services. 3 core items: 1. Learned from Experience 2. Learned through experience of academic learning 3. Learned through social experience. Plan for Resolution (written letter to Student B and Family) and Reconnection to Student B must be determined and put into place with behavior contract including consequences if further incidents happen.

Changes in Intersession: Intersession would be before finals for instructional support before finals.

Laura Van Wormer – having intersession in mid-term instead of end of term. Striving towards proficiency through the term instead of at the end. Would be very beneficial for both staff and students.

Term 1: October 3-7

Term 2: March 20-24 (before parent/teacher conferences)

Term 3: June 19-23

Reaction from faculty- they are very supportive.

Recommendation – move dates to mid-term to ensure proficiency.

C. 9th Grade Cap Review

Approved 9th Grade Cap 2016-2017 -75

Matriculation agreement in the works for Paragon Charter Academy. Would like to extend opportunity.

Staffing - \$200,000+ coming in from students. Addition of 3 Early College staff.

Looking at hiring those that are dual certified that spans from 6th-13th grades.

Clarification: Taking in over 100 applicants – a waiting list would be created. Lotteries can only happen during open enrollment.

Dual enrollment cost could increase substantially. Students coming in are completing 8th grade, meaning they need to complete 1st year course work before dual enrollment.

Recommendation: open 9th grade cap to 100 students

Motion to approve 9th grade cap to 100 – Rando, Second – Wilcox, Support – Williams, Approved.

D. Job Descriptions

All descriptions are full time with the exception being the accountant being part time. Motion to accept proposed (6) descriptions and to amend charter at the upcoming meeting – Rando, Second – Hogwood, Unanimous. Approved.

Details revenue expense statement. President and accounting dept. will be going over another proposed budget.

Miscellaneous category – startup costs. Invoiced to charter.

April financial Statement – how state aid revenue is stated, its only reflected of actual dollars.

B. Budget Proposal

Initial draft for board review.

Budget proposal for 2016-2017 for enrollment of 330 students. \$7,391/pupil. Added in are dollars for Title 1 monies, 64b, state funding for dual enrollment (not guaranteed). Expenses – general/instructional/fees to college (\$150,000 – lease), startup costs (\$90,000)/dual enrollment (\$500,000)/Cash reserve (\$100,000).

10% of 3.5-4 million for building 1.5 years from current date.

Current enrollment for 2017-2017 is at 349.

E. Faculty Salaries

Salary increases – sheet provided is current salaries, no raises are included in the budget proposal. Last year JPEC was able to provide a 3% increase in salary. Rather than 3% increase, include a set stipend to allow more flexibility. Contracts would not be extended until after June, with an approved budget. Increase of \$37,500 in raises at 3%.

F. Options for Accounting Support

Utilize schools/individuals to support JPEC. Looking outside Jackson County and if they are interested in contracting out to JPEC. Substituting the part time accounting job.

Contact with American Honors and other international programs. American Honors has asked to travel to China. Jonathon Marowelli will be traveling to China to explore the options. Lead for foreign language teacher, certified in 7 different languages, with a Ph.D. Resume has been sent, interview should be following.

i. Subcommittee work

Creating a curriculum/pathway that starts at the 6th grade. Starting with big picture goals – aligning GEO's with JC. Would like to have a set of skills that aligns with all departments using the same vocabulary and skill sets.

Moving forward for presentation on May 17th – 9:00am in Flint. When JPEC presents that they bring a team to present. Open invitation to be present at the presentation or record perspective on JPEC.



C. NWEA Assessment Update

Being intentional with what these numbers mean in the student's eyes. No more science in NWEA – it does not align with next generation science standards, at the EC level it doesn't take into account specialized science courses. Replacing that test – pulling ACT questions or SAT questions and creating our own testing.
