- Foundation allowance increased \$120. \$7,511 per student was assumed.
- Assumed use of \$22,500 in At Risk funds and approximately \$33,000 in Title funds.
- Revenue per pupil estimated at \$7,798 for 330 students.
- Miscellaneous included athletic Pay-to-Play fee and AUP technology fee.
- Dual enrollment has been increased to \$500,000 for three terms.
- Owed to JC: start-up cost, lease, and support with start-up items.
- Plans to review budget 4 times throughout 2016/2017.
- Adding under Major Assumptions to state JPEC will start to reduce the debt to JC in the 2016-2017 budget.

8. Information Items

- Markowski & Co. Accounting.
 - July 1, 2016 JPEC will move away from JC's accounting services.
 - Markowski would be a fast transition for JPEC. Also a large financial difference, proposed \$1,600/month \$19,200 annually. Price includes accountant and counseling to school on financials.
 - Markowski feels comfortable with the transition and has experience with school financials.
 - Other option is for a part time accountant in house. Two candidates have been interviewed and are comfortable with the position.

9. Additional Updates

- Update on board member: documents have been sent and should be included in JC packet for July 11 meeting.
- Matriculation agreement with Paragon: Has declined the agreement. Without JPEC being at capacity yet, there is no need for a matriculation agreement. We will revisit in future years.
- Add in board member nametags for picnic.
- McDonald's gives scholarships per semester for employees, up to \$750/semester.
