 - A. Count Day Update

CP and *EC* have separate schedules. *EC* had 2 count days Oct 4 and 5. 400 students counted. Did reconcile some absences. System and prep was better than any year. Have to account for attendance every hour, weren't able to count every hour. Lost .98 *FTE*, but lowest in school history.

For financial accounting, count day is a 90/10 blend. 90% given at first count day and 10% on the second count day.

Lessons Learned – difference between applications in hand and word of mouth. Also difference between enrollment papers turned in and applications received. Early college enrollment is still increasing while CP has plateaued.

i. September Financials

Have accrued for \$829,896, received \$0 as of today.
Expenses, \$242,080.
Received \$17,000 in AUP and athletic fees from student body.
*Have had computer damage, mainly screen breakage due to age and use.
Have paid for majority of curricular licenses.
Paid attorney fees in full. Will need to make an adjustment in budget as additional costs have been billed due to new building construction.
End of September, \$163,000 in cash which covered needs. No need for short term financing. All supplies was provided and covered.
2/3 of spring tuition, June, July, and August rent, and Covalle Architects was paid.
Cashflow Forecast
Started month with \$324,000. Computer supplies and payroll were major

expenses. Also substitute teaching costs were increased due to shortage in staff.

Plan to make a substantial payment to Jackson College when we receive the November state aid payment. Slowly pay college in full by April (including rent and all tuition payments) Rent per month is \$12,500.

- iii. Outstanding Invoices Covalle, Mercer, Driesenga and other bills have been paid. Jackson College is in a payment period.
- iv. Budget Amendment I Draft
 State will pay 90% of current count and 10% of last years count.
 \$220,000 less in cash than what was anticipating.
 Original budget included 2 additional staff members, that was cut. Saved.
 Line items for furniture and equipment have been added.
 Saved \$20,000 because of merge of in house technology maintenance.
 Paying more out of Title II for teacher PD and less in teacher mentoring.
 Line item addition of Architecture and Engineering Fees where Covalle,
 Mercer, and Driesenga fees are being accounted for.
 \$300,000 have been set aside for fees regarding the new building.
 Governor's comment: Have conversation with authorizer about fees prior to building construction and who will have to pay those fees.
 16.7% for fund balance.

 - a) Annual Education Report Same data from last year, because of transition from MEAP to MSTEP 2016-17 has not been released.
 - b) Student Learning Monitoring Report Growth in student demographics, and curriculum! Accountability measures that are changing in state such as scorecard.

Don Cooper has resigned from NCSI and has taken a position at GVSU as the director of charter schools.

Conversations are already in progress for a replacement.
